# Superintendent's Report

Mrs. Bason highlighted that the art show will be held at the high school on March 21, 22, and 23, 2018. There will also be an open house at the high school on Friday April 6, 2018 from 6:00-8:00pm. An Act 80 day is being requested for April 3, 2018 for Loyalsock Valley and Lyter Elementary teachers. Wonder Works training will be held that day at the elementary schools. Dr. Seuss week was a success with board members and staff reading to our elementary students. Kindergarten registration numbers are in with 52 students at Loyalsock Valley and 81 at Lyter Elementary.

Mrs. Bason mentioned the partnership between Montoursville Area School District and Lycoming College for a STEM Scholars Program. Students will have the opportunity to take classes at Lycoming College and receive college credits for those courses. Mrs. Bason announced that students at the high school would like to do a "Stand with Parkland" memorial service on March 14, 2018 to honor those who lost their lives at Marjory Stoneman Douglas High School.

Mrs. Bason requested a discussion on the direction for the district's food service department. Mr. Shimmel would like to submit a request for proposal for a food service company. Mr. Konkle agreed that a food service vendor would be the best option. Mrs. Marriott and Mr. Ruffing agree and also mentioned the success that other school districts have with this option. Mr. Shimmel stated that more students would participate with the various food selection. Mr. Snell has a concern with maintaining the current staff. Mr. Konkle mentioned that the board does care about the staff and they want to keep them. Dr. Mathers agreed with the comments. Mr. Shimmel commented that change can be difficult, but with the models of success all around us from other districts, he believes MASD can be successful too. Mr. Snell asked about the staff members who choose to be employed by the food service company, and if they could apply for unemployment in the summer. Mrs. Bason replied to the question.
