Mr. Saul presented a recommendation for the approval of a rate change to the school bus contract with **Promised Land Bussing** for bus #20 from \$495.84 to \$343.29 per day effective December 9, 2013; for bus #21 from \$262.76 to \$244.32 per day effective December 4, 2013; for bus #21 from \$244.32 per day to 247.20 per day effective December 9, 2013; and for bus #22 from \$226.86 to \$223.04 per day effective December 11, 2013; all due to changes in the routes to meet student needs.
